- Format of Event -
  - Brief speech/introduction/presentation
  - Setup different breakout tables, in a Trade Show format for stakeholders who provide services:
    - examples Conservation Authorities, waste management, etc.
- Public Survey -
  - Survey results could help guide discussions
  - Potential to group initiatives into categories
  - Potential to include an overview at beginning of survey explaining municipality's role in initiatives
  - Municipal staff can submit initiatives as well
- Budget determining amount that the public is willing to invest in environmental initiatives
