NOTIFICATION OF NON-COMPLIANCE

Re: Notification of Non-compliance with ECA Effluent Limit

This is a notification of non-compliance with an effluent limit at the Thorndale Wastewater Treatment Plant that is being submitted in accordance with the terms and conditions of Environmental Compliance Approval 0955-8MKJNP, and provisions of the *Ontario Water Resources Act* and *Environmental Protection Act*. This written notice confirms the verbal notification provided to Andrew Winkler on May 3th, 2023.

The following effluent parameter(s) were exceeded:

Comments/Actions Taken:

The monthly geometric mean for effluent E.coli, monthly average concentration for effluent total suspended solids (TSS), and monthly average TSS loading were exceeded during the month of April, 2023. This exceedance was caused by a heavy rainfall event that occurred on April 1st, 2023. As per the Environmental Compliance Approval 0955-8MKJNP, the UV disinfection system is designed to handle a peak flow rate of 2,436m³/day which was exceeded on April 1st. On April 1st, the total daily flow treated at the facility was 3,706.34m³. The monthly average daily flow for the month was 499.9 m³/day.

The increase in flow due to the heavy rainfall caused the Thorndale WWTP to operate in storm mode which reduces the cycle time periods by 25% to process flows up to the peak flow rate. Additional grab samples were collected during this peak flow rate exceedance to capture the effluent quality and monitor plant performance. Excluding the additional sample, all other E.coli and TSS sample results and loadings during the month of April would have averaged within the compliance limits.



The following table outlines the individual sample results as reported by SGS Laboratories for the month of April:
