

Community Grants Program Application Form

Criteria

- 1. Applications are due on May 1, 2024, by 4:00pm. Exemptions at the discretion of Council.
- 2. Applications must be submitted via email to communitygrants@thamescentre.on.ca or a hard copy dropped off at the front desk of the Municipal Office at: Municipality of Thames Centre, 4305 Hamilton Road, Dorchester, ON NoL 1G3.
- 3. Preference will be given to applications which meet one or more priorities set out in the Thames Centre Strategic Plan. In addition, applications should demonstrate community support, efficient use of resources and sound business practices.
- 4. To be eligible, applicants must provide products/services to the residents of Thames Centre.
- 5. Limit of one application per organization.
- 6. Individuals are not eligible to apply.
- 7. Each application must demonstrate that:
 - a. This grant is not the primary source of funding for the project
 - b. Financial assistance is needed as other sources lack adequate funding
- 8. The applicant organization must spend the grand funding on the sole purpose for which it was awarded within the fiscal year for which it is awarded.
- 9. Applicants will be deemed ineligible from future grants if they fail to provide written confirmation of how and where the grant funds awarded in previous years were expended.
- 10. Grants in one year or over several years don't guarantee future funding commitments
- 11. Payment Successful applicants will be paid in full, however grant recipients will need to provide written confirmation of how and where the grant funds were expended by end of the year. Failure to do so may eliminate them from future grant funding consideration.
- 12. The maximum allowable grant is \$10,000.00,
- 13. Applications for "in kind" non-financial assistance will be forwarded to the respective department for review with a report to Council for consideration and approval.
- 14. Successful grant recipients agree to acknowledge the support of the Municipality of Thames Centre in all printed material and through other promotional means.
- 15. The Municipality of Thames Centre should be informed if the project is delayed or changed substantially for any reason. In the event that the project does not go forward, the application will return those funds granted for the proposed project.

I am writing you this letter on behalf of the Belmont, Aylmer, Dorchester Girls Hockey Association ("BADGHA") to show our support for a monetary grant through your Council.

I believe our Association is deserving of this grant because of our commitment to help young girls get involved with hockey. The sport of hockey has undeniably positive impacts on the people who play, and we believe those impacts should be shared by all. One of our biggest struggles with girls' hockey is that it remains underfunded and poorly supported. To ensure that we achieve a long-lasting and genuinely positive impact on the female game, we have focused our funding into three strategic imperatives – development, recruitment, and retention of girls in the sport.

One of the reasons I support the BADGHA is that we provide quality hockey programs to our youth girls at a reasonable cost across Belmont, Aylmer, and the Dorchester area. New this year, our Association introduced a Fundamentals Program. It is an all-ages introduction to female hockey that is free for the participants. The program removes financial barriers to participation, while providing a safe environment where the girls can be themselves, learn and have fun.

Another reason I believe the BADGHA is deserving of this grant is that I know that the money will go directly back into the communities it serves. If you choose to award your grant to the BADGHA, we plan

on using the funding on our new Fundamentals Program so that we may expand our hockey program and continue to help families make this sport affordable for their children. I believe that BADGHA can exceed your expectations and continue to flourish with your assistance.

Further, due to the constantly rising operational costs, ice rentals and referees specifically, very little of our budget is left to update aging equipment and apparel. BADGHA, if awarded, would like to use some of the grant money to update our jerseys and purchase additional jerseys to support the growing number of girls playing hockey in our Association.
