6. Reports of Staff

6.1 Municipal Office - Energy Audit Report

Member McClure arrived at 11:40 a.m.

D. Barrick, Chief Administrative Officer, provided background on the Energy Audit Report for the Municipal Office.

The Committee inquired about future plans relating to the energy audit, and if this will be completed for the other municipal buildings.

Staff advised that the original intention of this audit is for grant application eligibility, and that there are general plans to complete this for all other

facilities, including the FlightExec Centre where there is a lot of energy consumption.

The Committee discussed long-term cost savings and decreasing the burden to taxpayers through grants, and also debated whether the cost of natural increase would rise or not.

6.2 Partners for Climate Protection Program

Chair Lockie provided background on the Partners for Climate Protection Program and opened the floor for the Committee to discuss if the potential allocation of \$25,000 is a good use of funds or not.

The Committee compared the two (2) separate programs - Partners for Climate Protection Program (PCP) and the Building Adaptive and Resilient Communities Program (BARC) and discussed the full costs and features of each program, as well as long-term initiatives and impacts.

The Committee inquired about the recommended utilization of one-time funding of \$25,000 from the Tax Stabilization Reserve to be used towards the PCP Program for Corporate Benchmarking, including, a retroactive analysis of Municipal energy consumption and greenhouse gas emissions.

D. Barrick, Chief Administrative Officer, advised there would be a commitment to fulfill obligations as a Municipality, as the work does require additional assistance initially to get started. D. Barrick further advised this amount could either be considered by Council in 2024 or be referred to the 2025 Budget Deliberations.

The Committee discussed potential financial obligations to the BARC Program, being a \$20,000 annual commitment.

The Committee discussed building assessments and advocating for capital improvements, as well as grant funding eligibility.

The Committee provided direction to staff not to join the BARC program at this time.

AND THAT the Environmental Advisory Committee (EAC) recommend to Council that the Resolution to Join the FCM—ICLEI Partners for Climate Protection Program **BE ADOPTED** as follows:

WHEREAS The Federation of Canadian Municipalities (FCM) and ICLEI—Local Governments for Sustainability (ICLEI Canada) have established the Partners for Climate Protection (PCP) program to provide a forum for municipal governments to share their knowledge and experience with other municipal governments on how to reduce GHG emissions:

WHEREAS over 350 municipal governments across Canada representing more than 65 percent of the population have already committed to reducing corporate and community GHG emissions through the PCP program since its inception in 1994;

WHEREAS the PCP program is based on a five-milestone framework that involves completing a GHG inventory and forecast, setting a GHG reduction target, developing a local action plan, implementing the plan, and monitoring progress and reporting results;

BE IT RESOLVED that the Municipality of Thames Centre review the guidelines on PCP Member Benefits and Responsibilities and then communicate to FCM and ICLEI Canada its participation in the PCP program and its commitment to achieving the milestones set out in the PCP five-milestone framework;

BE IT FURTHER RESOLVED that the Chair of the Environmental Advisory Committee and the CAO be appointed to oversee the implementation of the PCP milestones and be the points of contact for the PCP program within the Municipality.

AND THAT one-time funding of \$25,000 from the Tax Stabilization Reserve be authorized for utilization toward this Program for Corporate Benchmarking, including, a retroactive analysis of Municipal energy consumption and greenhouse gas emissions.

The Committee discussed the wording of draft survey questions as presented, and also discussed potential new survey questions.

The Committee discussed Section 3 of the Draft Survey, "Program Feedback" to potentially include a link or description to provide additional information regarding these programs.

The Committee discussed the format of the upcoming Green Town Halls, including how to display survey results and potentially facilitating 3-5 concurrent smaller roundtable discussions.

The Committee further discussed how to explain the purpose of the Green Town Halls, which is to engage with the public and obtain feedback for an action plan on climate change, and to explain this in advertising and at each town hall event.

The Committee discussed the timeframe for survey completion, as well as the tentatively scheduled dates for the Green Town Halls.

The Committee discussed how to invite members of the public, as well as stakeholders and organizations.

The Committee directed staff to present the survey results to the Committee, in advance of the Green Town Halls, at the next regular meeting.
