RECOMMENDATION:

AND THAT the draft new Terms of Reference for the Thames Centre Active Living Centre Advisory Committee **BE APPROVED**.

PURPOSE:

The purpose of this report is to seek Council's approval regarding two minor amendments to the Terms of Reference for the Thames Centre Active Living Centre Advisory Committee.

BACKGROUND:

At the regular meeting of the Thames Centre Active Living Centre Advisory Committee held on Friday, April 25, 2025, the Committee discussed its Terms of Reference and the current recommended composition of members, which includes two (2) Dorchester & District Lions Club Members.

The Committee discussed the benefits of including representation from both the Dorchester and Thorndale Lions Clubs and passed the following resolution to be approved by Council:

THAT the Terms of Reference for the Thames Centre Active Living Centre Advisory Committee **BE AMENDED** to include the following Committee Composition:

- 4 Residents (not required to be a Lions Active Living Centre Member)
- 1 Dorchester & District Lions Club Member

- 1 Thorndale Lions Club Member
- 2 Lions Active Living Centre Members (pay membership and are active in programs)

Carried.

The Committee also discussed the requirement under the current Terms of Reference to only hold committee meetings at the FlightExec Centre in Dorchester. The Committee currently alternates its meeting locations between both Active Living Centre locations in Dorchester and Thorndale. It is staff's recommendation that the current Terms of Reference be amended under "Meetings" to include both locations.

COMMENTS:

As per the current Terms of Reference as well as the new proposed version, the committee composition includes a maximum of eight (8) voting members and **may** be composed of specific types of representatives, *when possible*. This wording provides flexibility of members for this Committee, and amending the recommended composition doesn't actually impact any formal requirements.

As per this Committee's Terms of Reference, "Any changes proposed to these Terms of Reference by the Committee shall be recommended to Council." These minor changes are to ensure this Committee's Terms of Reference are accurate and up-to-date.
