# 6.1 Charity Depot Presentation

Mayor McMillan advised that this year's Charity Depots were held in Dorchester on Saturday, May 3, 2025 and in Thorndale on Saturday, May 10, 2025.

Mayor McMillan advised that at a Charity Depot, residents deliver unwanted scrap metals, used batteries, and aluminum cans to Depot locations, where volunteers assist in unloading the items, so they can be sent to local metal recyclers to be weighed and exchanged for fair market value.

Mayor McMillan advised that the funds raised from the Charity Depots would be shared between the MS Bike Ride, the Optimist Club of North Dorchester and the Thorndale Optimist Club.

Mayor McMillan and Jarrod Craven, Director of Public Works, presented the Charity Depot cheques, each in the amount of \$1,179.43, to Barry Travnicek on behalf of the MS Bike Ride, John Andrigo on behalf of the Optimist Club of North Dorchester, and Bob Graham on behalf of the Thorndale Optimist Club.

Mayor McMillan thanked everyone for supporting the Charity Depots in the Dorchester and Thorndale communities.

## 6.2 PSD CityWide - Asset Management Plan 2025

Jasmine Shadd, of PSD CityWide was in attendance and provided a presentation on "Asset Management Plan 2025", as appended to the agenda.

Council inquired about factoring in reserve funds and inflation; climate change's impact on investing in stormwater and if a study is recommended; replacement costs and spending for machinery and equipment; the Asset Management Plan aligning with the strategy from Watson and Associates; and if increases were year over year.

Council discussed the benefits of staff reporting to Council on the impact to the asset management plan when presenting capital items to Council, to better evaluate the long-term financial cost for that asset.
