**AND THAT** the Recommendations section of the Draft 2024-2027 Strategic Plan, Active Living section, be amended by replacing 4D with, "The Municipality should work with existing partners to support the Playroom and Youth Centre in the urban centres of Dorchester and Thorndale.";

**AND THAT** the Recommendations section of the Draft 2024-2027 Strategic Plan, Municipal Services section be amended by adding a 6E, "The Municipality should form an Ad Hoc Doctor Recruitment Committee";

**AND THAT** the Recommendations section of the Draft 2024-2027 Strategic Plan, be amended by adding Section 7: Sustainability;

**AND THAT** the Recommendations section of the Draft 2024-2027 Strategic Plan, be amended by adding the following;

- "7A The Municipality should establish a Reserve Fund Policy and review this policy annually.
- 7B The Municipality should ensure that it acts with fiscal prudence to maintain affordable and sustainable taxation levels.
- 7C -The Municipality should prioritize green initiatives and work with the Thames Centre Environmental Advisory Committee closely.
- 7D The Municipality should develop a Tree Planting Program and ensure that funding is made available for this initiative.";

**AND THAT** 6B be replaced with, "The Municipality should develop a Water and Wastewater Master Plan to address future needs and planning initiatives. The Municipality should explore cost-saving measures without compromising the service and safety of water quality.";
