SUBJECT: TRANSITION TO NEW MIDDLESEX O.P.P. DETACHMENT BOARD

### RECOMMENDATION:

**THAT** Report No. LS-C-001-24 be received for information;

**AND THAT** Council choose to appoint one (1) Council representative to the new Middlesex Ontario Provincial Police (OPP) Detachment Board;

AND THAT Council nominates the current Thames Centre Police Service Board Chair, Jim Maudsley, to support the Board transition as one of the two Community Representatives; AND THAT this resolution, including the name of the selected Council appointee and nominated community representative, Jim Maudsley, be forwarded to the local municipalities that form the Middlesex OPP Detachment service area for information and consideration to support the community member nomination.

### PURPOSE:

The purpose of this report is to provide information to Council regarding the new Middlesex Ontario Provincial Police (OPP) Detachment Board, and to seek direction regarding this transition and appointment for one (1) representative from the Municipality of Thames Centre Council.

### BACKGROUND:

At its regular meeting held on November 14, 2023, Report No. CLERK-015-23 was presented to Council regarding the *Community Safety and Policing Act* (CSPA) and the upcoming transition to a new OPP Detachment Board. Since that meeting, it has been announced that this Act will come into force on April 1, 2024, which will automatically dissolve the Thames Centre Police services Board.

At the January 16, 2024 meeting of Middlesex County Council, Jim Maudsley and Lisa Darling, representatives of the Ontario Association of Police Services Boards (OAPSB), provided a presentation to the Committee of the Whole regarding these legislative changes and the tasks that need to be completed in advance of the in-force day of April 1st.

In order to assist with the transition to the new OPP Detachment Board, and facilitate the mandatory training required, staff are recommending that Thames Centre move forward with its appointment to the new board and advising the other local municipal partners.

A proposal for the new OPP Detachment Board framework to the Ministry of the Solicitor General was received and approved. The new board official composition information is also attached to this report.

The next meeting of the Thames Centre Police Services Board is scheduled for <u>Tuesday</u>, <u>February 13, 2024 at 4:00 p.m.</u> in the Council Chambers at the Municipal Office.

### COMMENTS:

In consultation with Provincial representatives, OAPSB and local municipal CAOs, the first step to an effective transition in compliance with the April 1<sup>st</sup>, 2024 deadline is the appointment of members to the new board. Once members are appointed, required training can be completed and the new Board can begin making decisions and recommendations to the local municipalities on next steps related to budget/billing, administration, bylaws, etc.

There is potential for a Working Group to be formed to support the transition to the new Board.

## OPP Detachment Boards

Municipalities' responsibilities in Getting Ready for the CSPA

Lisa Darling - Executive Director

Jim Maudsley - Director

The CSPA was proclaimed on December 18, 2023 with an in-force date of April 1<sup>st</sup> 2024 Mandatory training of Roles and Responsibilities under the act - completed by in-force date.

- approximately 3 hours of remote learning (online)
- Must be completed to be an active voting member of the board.

### Note:

Additional mandatory thematic training on Human Rights, Anti Racism, the rights and cultures of First Nation, Inuit and Métis Peoples to be completed within 6 months of in-force date.

\*\*\*OAPSB is supporting boards through the transition by providing ancillary training directed at practical application of boards roles and responsibilities under the act. \*\*\*

Municipal Police Services Board and OPP policed municipalities

Strathroy Caradoc PSB members have completed the training and begin working on updating by-laws and policies.

Under the act it is the Police Services Board's responsibility to ensure adequate and effective policing.

Structurally, limited impacts across the province for Municipal PSBs to prepare for the change to the CSPA – much work required for bylaws, policies etc.

Focus for today on OPP policed municipalities

Experiencing significant change in structure in preparation for the in-force date of the CSPA.

# Detachment Board and Municipalities Discussion


The OAPSB recommends once the Boards have had a chance to meet and identify key items that they set up a meeting with the Municipality/ Municipalities.



## Requirements for Municipalities in the process of creating Detachment Board under the CSPA.

- Confirm <u>municipal</u> appointments and <u>Board</u> members to the Detachment Board
- O What will be the estimate breakdown: how will costs be apportioned? (example next slide)
- O How will the other municipalities make payments, one upfront, two payments?
- O What will be the process for the expense payments?
- Remuneration once Ministry regulations are posted
  - Amounts will need to be confirmed- especially if currently Board members are being paid different amounts.
  - O All appointees will need to be added to the Municipality paying the expenses? Or a process set up, contract?
  - what will the Administrator be paid, not covered under CSPA? Will Administrator be submitting invoices? Cost sharing?

### Detachment Board and Municipality Discussion

### Insurance

- Municipalities will need to work with their respective insurance companies to understand coverage for the Detachment Board, noting there could be an Administrator, Provincial appointees and Board members from other municipalities
- Estimates (Budget) process
  - What will be the format for the estimates to be sent to the Municipalities, what specific processes need to be followed

### Assets

- O Will Board assets be from one Municipality and a shared cost?
- Where will Board documents be housed/stored? Physical and virtual storage?
- What Assets are needed? Computers, printers, cell phone?

## Detachment Board and Municipality discussion

- Information Technology
  - Will a Municipality provide IT support services? Cost sharing?
  - Website- will the Board be posting to all municipal websites? Or will the Municipality that provides It support Services host the Board website?
  - Email addresses for Board members? Public contact information?

Greetings Michael Di Lullo,

Thank you for submitting your proposal for the Ontario Provincial Police (OPP) detachment board framework. Your patience has been greatly appreciated while all proposals went through a thorough review process.

At this time, I am pleased to confirm that the Middlesex OPP detachment board proposal has been approved by the Solicitor General to the next step in finalizing the board compositions, which is posting the composition on the Ontario Regulatory Registry (ORR). The ministry is currently working on drafting the regulation, which is expected to be available on the Ontario Regulatory Registry (ORR) for public comment in the summer or fall. Posting of the regulation is one of the last steps before the regulation can be finalized in advance of bringing the *Community Safety and Policing Act, 2019* (CSPA) into force in early 2024.
