10.1.1 Creation of a Recognition Program for Land Stewardship

Creation of a Recognition Program for Land Stewardship

THAT the Environmental Advisory Committee (EAC) recommends to Council the creation of a recognition program for land stewardship;

AND THAT two awards be given on an annual basis:

- Green Champion Award to a qualified individual who has demonstrated excellence in advancing a green initiative and is a resident of Thames Centre; and
- Community Champion Award to a qualified applicant who has demonstrated environmental leadership within a community organization within Thames Centre.

of transfer payment is not provided within 10 days of issuance of the consent certificate, the Applicant's solicitor further undertakes to forthwith apply in writing to the Municipality for the issuance of a certificate of cancellation of the consent certificate.

2.2 That the Applicant compensate the Municipality for all legal costs incurred to the Middlesex County Barrister & Solicitor's Office in resolving the Shackleton severance, proceeds and tax matter."
