# Canada Day

#### **BridgeFest**

- Relocation moving from bridge/Hamilton Road to Dorchester Community Park
  - Large effort to close the road
    - minimal set up time for staff
    - 401 overpass construction road closure is not guaranteed
  - Large effort moving required assets to location
    - power, stage, lighting, etc.
    - amenities already exist at the park
  - o Dorchester Community Park
    - lots of seating and shade
    - accessible pathway
    - lots of parking
- Renaming to "CornFest"
  - o Committee can discuss other types of events on bridge in future

# Movie Nights

Reducing the number of Movie Nights in the summer to 2 (1 in Dorchester & 1 in Thorndale)

- Low attendance
- · Possibility for Dippin Dotz, ice cream trucks, etc.
